#### **Background to qualification review**

Skills for Care has reviewed and updated the Level 3 and Level 5 Diplomas in Adult Care.

During the consultation and development process, they engaged with a wide range of sector stakeholders and subject matter experts, ensuring that the content and assessment criteria meets the needs of employers and learners.
